## Homeland Security TOPOFF 3 Exercise

### SEMARA ARES / SEMARA MEMBERS SUPPORT TOPOFF 3 IN CONNECTICUT

Scenario for the Department of Homeland Security's TOPOFF 3 Exercise that occurred in Connecticut and also in New Jersey: "A mass casualty incident occurred and is an act of terrorism." Similar national exercises have been conducted in several parts of the US over the past several years.

Eastern Massachusetts responded with an ARESMAT (Mobile Activation Team) to the affected area of Connecticut and in that ARESMAT were largely Amateurs from SEMARA ARES as well as a SEMARA member from Cape Cod ARES.

**Dan Howard, K1DYO** (SEMARA member from the Cape Cod ARES team), **Arthur Irwin, W1AEI**, and **Brad Anselmo, N1VUF**, comprised a 4-man team that was led by Eastern Massachusetts ARRL Section Manager **Mike Neilsen, W1MPN**, to the New London, CT area. Communications support for the Red Cross was completed in this area to support Connecticut ARES. The request for support from Eastern Massachusetts ARES came from ARES Section Emergency Coordinator for Connecticut, **Chuck Rexroad, AB1CR**.

The team performed communications in and around a secure area of New London Connecticut when an act of terrorism occurred. Tactical and formal message traffic was handled to support Red Cross. The amateurs from the ARESMAT reported that the event went very well from a communications perspective

and they all felt they were integrated into operations. **Betsey Doane, K1EIC**, Connecticut ARES Section Manager and **Chuck Rexroad** commended and thanked **Mike Neilsen, W1MPN**, for leading the team to Connecticut and **Rob Macedo, KD1CY** for organizing the team and providing logistical support.

**Bob Kelley, K1KVV**, and **Byron Piette, K1YCQ**, offered their support for handling communications from Southeastern Massachusetts into the state of Connecticut. While their support was not utilized because the Connecticut section was busy handling the incident locally, they were prepared to offer critical relay support into and out of the affected area either from the SEMARA club station or as home relay stations.

The SEMARA Club is establishing itself as a hub for emergency and public service communications. 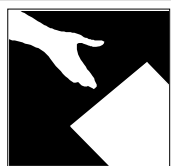

# Amateur Radio Today

## GERMANY & SPAIN CHANGE AMATEUR REGULATIONS

*The ARRL Letter*  
Vol. 24, No. 10—March 11, 2005

Germany and Spain have recently announced changes in their Amateur Radio regulations. Some revisions stem from the outcome of World Radiocommunication Conference 2003, which essentially left it up to individual countries to decide if they wanted to continue to impose a Morse code requirement for HF access.

In Germany, the Deutscher Amateur Radio Club (DARC) reports that, effective February 19, there now are only two classes of Amateur Radio license: Class A (formerly Class B and C) and Class E (formerly Class D). The new Class A works in accordance with the Harmonized Amateur Radio Examination Certificate (HAREC), T/R 61-02. It permits radio amateurs in participating European countries to go from one European nation to another and obtain a full license. (Note: The US does not participate in HAREC.)

Longtime visitors or foreign residents with a CEPT license in Germany will be issued a German Class A license. The Class E license remains limited to VHF/UHF frequencies only, with the addition of 10 GHz, output limited to 10 W EIRP. There also have been some changes to the spectrum allocation at 1.8 MHz. In Spain, the Unión De Radioaficionados Españoles (URE) reports two significant changes in that country's Amateur Radio regulations, effective March 3: Spain has deleted the Morse code requirement to obtain a Class A (General) or Class C (Novice) license. Also, Class A (General) and Class B (Restricted) licensees now are allowed to use the band 50.0 to 51.0 MHz "under special and particular authorization."

## INTERNATIONAL THIRD-PARTY TRAFFIC

Occasionally, DX stations may ask you to pass a third-party message to a friend or relative in the States. This is all right as long as the US has signed an official third-party traffic agreement with that particular country (see table on page 6), or the third party is a licensed amateur. The traffic must be noncommercial and of a personal, unimportant nature.

During an emergency, the US State Department will often work out a special temporary agreement with the country involved. But in normal times, never handle traffic without first making sure it is legally permitted.

The list of Third-Party Traffic Countries is in the right column on page 6.

US licensed amateurs may operate in the following US territories under their FCC license:

Northern Marianas Islands, Guam,  
Johnston Island, Midway Island,  
Kure Island, American Samoa,  
Wake Island, Wilkes Island, Peale Island,  
The Commonwealth of Puerto Rico, and  
US Virgin Islands.

Note that the Region 2 Division of the International Amateur Radio Union (IARU) has recommended that international traffic on the 20 and 15-meter bands be conducted on the following frequencies:

14.100-14.150 MHz  
14.250-14.350 MHz  
21.150-21.200 MHz  
21.300-21.450 MHz

The IARU is the alliance of Amateur Radio societies from around the world; Region 2 comprises member-societies in North, South and Central America, and the Caribbean.

**Note:** At the end of an exchange of third-party traffic with a station located in a foreign country, an FCC-licensed amateur must *transmit the call sign of the foreign station* as well as his own call sign.

## AMATEUR RADIO: OLD TECHNOLOGY?

Is that what the public thinks of Amateur Radio? Are they not aware of the many new technologies that amateurs use? Are they not are aware that many of today's new technologies were developed by amateurs working for major companies. Are they not aware that almost all the astronauts are licensed amateurs?

**F**ellow amateurs and amateurs-to-be, we need to do some *educating*! The general public needs to be shown what Amateur Radio is all about!

**Next time you are operating at a public event**, think about showing them how a GPS unit connected to your rig works. Show them how Echo-Link works. Show them every chance you get that we are on the cutting edge of technology.

## CUT NUMBERS

**I**t is common for operators, in an effort to minimize ANY unnecessary effort, to use "cut numbers." *Cut numbers* are abbreviated forms of *numbers*, expressed as *letters*:

0 = T, A = 1, U = 2, ... , 9 = N

**G**enerally the other numbers are send as numbers, but "5NN T4" means "599 04". The cut numbers for zero and 9 are the most frequently used. However, in contests where the exchange is RST and POWER, you will often hear a station

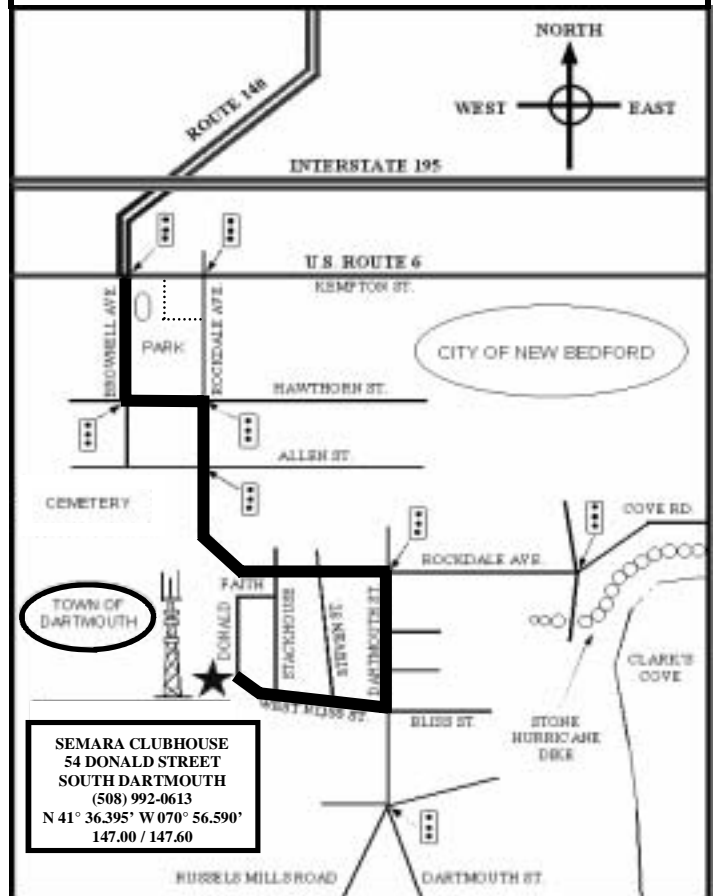
