The emphasis is on *rag-chewing* rather than fast contest-type exchanges. *SKN 2006* begins at **7:00 p.m. EST December 31** and runs for 24 hours (**0000-2400 UTC January 1, 2006**). For *SKN 2006*, send *SKN* in place of *RST* before sending the signal report. This alerts listeners that you are working *SKN*. After *SKN*, send your list of *stations worked* to <StraightKey@arrl.org> and include your vote for the *best fist* you heard (it doesn't have to be one you worked). Also, give your vote for the *most interesting* QSO you had or monitored.

Kid's Day is on **Sunday, January 8** beginning at **1:00 p.m. EST** and runs for 6 hours (1800Z to 2400Z). Come to the SEMARA radio room and show the kids our hobby! As always, there will be 2 HF stations ready to go on the preferred frequencies: 28350 to 28400 kHz, 21380 to 21400 kHz, 14270 to 14300 kHz; as well as on 2-meter simplex frequencies (except 146.520). Kid's will talk to other kids and exchange their name, age, location and favorite color. You are encouraged to work the same station again if an operator has changed. *Call "CQ Kid's Day."* All participants are eligible to receive a colorful certificate after completing the Kid's Day Survey at <<http://www.arrl.org/FandES/ead/kids-day-survey.html>>. If you know grade school kids in your neighborhood, invite them and their parents. This is a wonderful opportunity to share the wonder of Ham Radio.

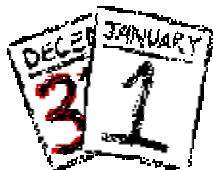

PROPOSED AMENDMENTS

First proposed Bylaw amendment

Make all existing language "Section 1 - Composition:

Add a section to Bylaw Article VIII - Committees:

Section 2 - Responsibility and Authority

All Committees shall be charged with the operation, repair, and maintenance functions in their respective area [sic]. Additionally, they shall be authorized to expend club funds up to one hundred dollars each month for repair and maintenance only. Unused funds shall not be carried into succeeding months. In no case shall Committees make substantial or major changes to their area or purchase new equipment, or accept donations, without prior Board of Directors review and membership approval.

Second Bylaw Amendment

Add a new section to Bylaw Article IV - Board of Directors:

Section 4 - Authority

A. The main function and charge of the Board of Directors is to review plans and items of interest to the Association and then make recommendations to the membership. The membership, by vote, shall accept or reject such plans or items of interest at a regularly scheduled or special business meeting. The membership shall reserve the right to modify, amend, limit or expand, or impose sanctions or conditions upon the scope of such plans or items prior to a vote.

B. Additionally, the Board of Directors shall have no authority to accept major donations, with a value greater than two hundred dollars, to the Association. They shall, however, recommend to the membership the acceptance or rejection of said major donations.

C. The Board of Directors shall have no authority to authorize any major changes to the club's infrastructure, including, but not limited to, the building, towers, antennas, and radio equipment including the club's repeater(s).

D. The Board of Directors shall have no authority to authorize the expenditure of Association funds, excepting emergencies as outlined in S[ub]section E.

E. In case of bona fide emergencies, the Board of Governors may authorize temporary measures, including the expenditure of club funds, to protect the club property and equipment. The membership, at the next business meeting, shall make the final determination relative to what final measures shall be authorized to address said emergency condition.

To be voted at the Jan. 5, 2006 business meeting.

BOARD OF DIRECTORS MEETING NOVEMBER 2005

Rob reports the processing application through Homeland Security for the generator is on going.

Scott reports the insurance rates have gone up and after discussion, the board advises that the body vote to decide on the 500 dollar or 2500 dollar deductible.

The Board also recommends that the body approve selling one of the old repeaters and keep the other complete one, for backup purposes.

HEAVY HITTERS TRAFFIC NET

Hi SEMARA,

Effective January 1st, the **Heavy Hitters Traffic Net**, which is a National Traffic System affiliated net for passing formal written messages between hams and non-hams, will be operating nightly at 10 p.m. on the *MMRA network*. Their nets generally run about 30 minutes.

The following repeaters will automatically link at 9:50 p.m.:

146.61, 146.67, 146.715, 146.820, 147.270,
and all 222 and 440 repeaters.

The repeaters will return to their normal state at 11:50 p.m.

On Tuesdays, the repeaters will link as they always have at 7:50 pm for the TIOS net, but will remain linked until 11:50 p.m.

Note that the 146.790 repeater in Weston will **NOT** link for HHTN, so it will remain on the previous schedule of 7:50 p.m. link – 9:50 p.m. unlink on Tuesdays only.

Although the net will not begin until January 1st, the scheduler set points have been programmed and the automatic linking will begin starting now. This gives us time to make sure everything is running smoothly.

D. There are no FCC Part 97 Rules about which side band is used on any band. Amateurs have adopted the practice of using lower sideband with frequencies less than 7.3 MHz and upper sideband on bands with frequencies higher than 14 MHz. This practice began in the early days of SSB operation, because of some design requirements of early SSB transmitters. [Note, only upper sideband is permitted on the 5-channels of the 60-meter band allocation. Ed.]

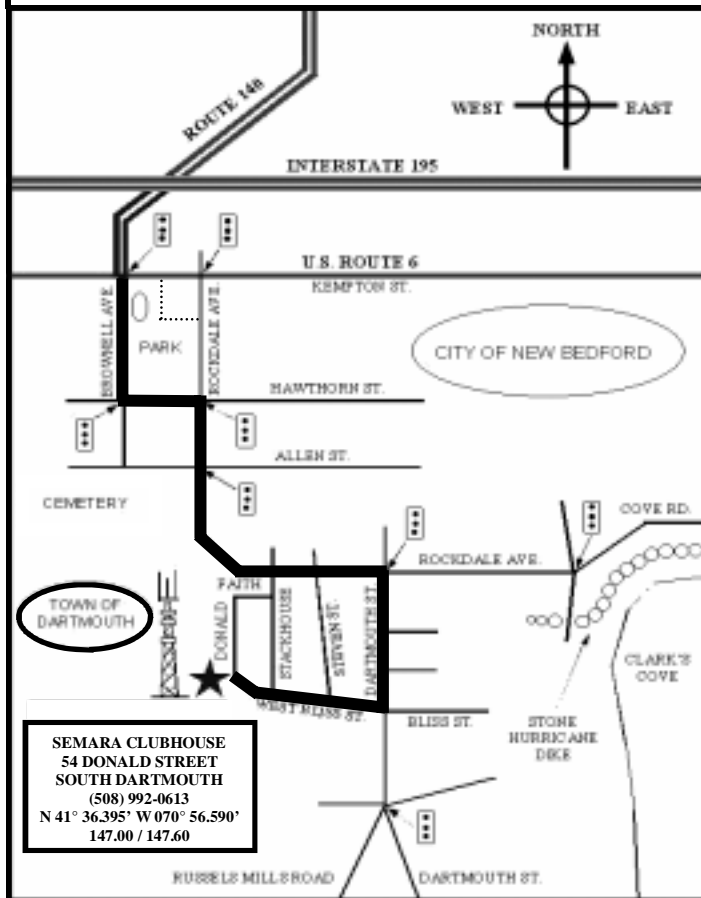
